

PRIVACY POLICY

This Privacy Policy explains how **Sports & Tech** collects, uses, and protects your personal information when you use the app. The App is designed to help investors in the fund that owns sports clubs manage ticket requests, receive updates, and engage with related content and activities.

1. Information We Collect

When you use the App, we may collect the following types of information:

a. Information you provide directly

- Name, email address, and contact details
- Investor/fund affiliation details (to verify your eligibility)
- Ticket request information (game, number of tickets, status of request)
- Profile information (such as profile photo, preferences)

b. Information we collect automatically

- Device information (model, OS, unique identifiers)
- Log information (IP address, browser type, usage data)
- Interaction data (features used, campaigns or suggestions viewed, communications opened)

c. Optional information

- Preferences on suggested activities (e.g., “where to eat,” “things to do,” clubs or events of interest)
- Feedback and communication through the App

2. How We Use Your Information

We use your information to:

- Process and manage ticket requests for matches and events
- Verify investor eligibility and provide appropriate access
- Send notifications, confirmations, and updates about your requests
- Suggest activities, events, or club-related opportunities
- Communicate important news, updates, or fund-related information

- Improve the App experience and develop new features
- Comply with legal and regulatory obligations

3. How We Share Your Information

We do not sell your personal information. We may share your information only in the following circumstances:

- **With service providers:** To support hosting, email delivery, or data analytics
- **With clubs or event organizers:** To process ticket requests or event access
- **For legal reasons:** When required by law, regulation, or legal process
- **Business purposes:** In the event of a merger, acquisition, or restructuring

4. Data Retention

We retain your personal information as long as necessary to provide the services described in this Privacy Policy, comply with legal obligations, resolve disputes, and enforce agreements.

5. Security

We implement reasonable technical and organizational measures to protect your personal data. However, no system is 100% secure, and we cannot guarantee absolute security.

6. Your Rights

Depending on your location, you may have the right to:

- Access the personal data we hold about you
- Request correction of inaccurate data
- Request deletion of your personal data
- Restrict or object to processing in certain cases
- Withdraw consent for communications at any time
